# **Privacy Policy**

At My Digital Bacon LLC, we are committed to protecting the privacy and security of our Users' information. This Privacy Policy outlines how we collect, use, and disclose the personal information we obtain from Users of our webhosting platform that is accessible for VR websites.

#### **INTERPRETATION & DEFINITIONS**

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear singular or plural.

- "Platform" refers to the webhosting platform developed and operated by My Digital Bacon LLC, accessible at https://mydigitalbacon.com.
- "Personal information" refers to any information that identifies or can be used to identify an individual, such as name, address, email address, phone number, payment information, or other information that can be linked to an individual.
- "User" refers to any individual or entity that uses or accesses the Platform, including but not limited to customers, visitors, and any person that submits personal information to My Digital Bacon LLC through the Platform.
- "Account" means an individual account created for You to access our Service or parts of our Service.
- "Company" (referred to as either "the Company," "We," "Us," or "Our" in this Agreement) refers to My Digital Bacon LLC.
- "Device" means any device that can access the Service, such as a computer, a cellphone, or a digital tablet.
- 'Personal Data" is any information that relates to an identified or identifiable individual.
- "Service" refers to the website.
- "Service Provider" means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service, or to assist the Company in analyzing how the Service is used.
- "Third-party Social Media Service' refers to any website or social network website through which a User can log in or create an account to use the Service.

- 'Usage Data' refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).
- "You" mean the individual accessing or using the Service, the Company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

### **Acknowledgment and Consent**

By using the Platform, Users acknowledge that they have read this Privacy Policy and consent to the collection, use, and disclosure of their personal information as described herein.

## **Scope of this Policy**

This Privacy Policy applies solely to personal information collected by My Digital Bacon LLC through the Platform. It does not apply to information collected by third-party websites or services that may be linked to or from the Platform.

### **Information Collected:**

At My Digital Bacon LLC, accessible via https://mydigitalbacon.com, we recognize the importance of privacy and are committed to protecting the information we collect from our users. This Privacy Policy outlines the types of information we collect and how we use it.

When you sign up for our web hosting platform or use our website, we may collect the following information:

Personal Information: This includes your name, email address, phone number, billing information, and any other information you provide us when you sign up for our services.

- 1. **Website Information:** This includes the domain name of your website, the IP address of the server where your website is hosted, and any other information that is necessary to provide web hosting services to you.
- 2. **Usage Information:** This includes information about how you use our web hosting platform or website, such as the pages you visit, the features you use, and other similar information.

- 3. **Communication Information**: This includes any information you provide us when you contact us, such as your name, email address, and the content of your message.

#### We use this information to:

- 2. Communicate with you about our services, including billing and technical support.
- 3. Analyze usage patterns and improve the functionality of our web hosting platform or website.
- 4. Comply with legal and regulatory requirements.

We take appropriate measures to ensure the security of your personal information and protect it from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or electronic storage is completely secure, and we cannot guarantee the absolute security of your personal information.

We do not sell or rent your personal information to third parties without your consent, except as required by law. We may share your personal information with third-party service providers who help us provide our services, such as payment processors and data storage providers. We require these service providers to protect your personal information and only use it for the purposes for which we have engaged them.

We may also disclose your personal information to law enforcement agencies, government officials, or other third parties if we are required to do so by law or if we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request.

### **Disclosure of Information:**

At My Digital Bacon LLC, we understand the importance of protecting your personal information. We do not sell, trade, or rent your personal information to third parties for their marketing purposes without your consent. However, we may disclose your personal information in the following circumstances:

- Service Providers: We may share your personal information with third-party service
  providers who help us provide our services, such as payment processors, data storage
  providers, and website analytics companies. We require these service providers to protect
  your personal information and only use it for the purposes for which we have engaged
  them.
- 2. **Legal Requirements**: We may disclose your personal information to law enforcement agencies, government officials, or other third parties if we are required to do so by law, subpoena, court order, or other legal process, or if we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request.
- 3. **Business Transfers:** In the event that we sell or transfer some or all of our business or assets, we may disclose your personal information to the buyer or transferee as part of the transaction.
- 4. **Consent**: We may disclose your personal information to third parties with your consent.

We may also share aggregated or de-identified information that cannot be used to identify you with third parties for research or marketing purposes.

We take appropriate measures to ensure the security of your personal information and protect it from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or electronic storage is completely secure, and we cannot guarantee the absolute security of your personal information.

#### **Data Retention**

We will retain your personal information only for as long as necessary to fulfill the purposes for which we collected it, including for the purposes of satisfying any legal, accounting, or reporting requirements.

- 1. **Personal Information**: We will retain your personal information for as long as your account is active or as needed to provide you with our services. If you request that we delete your personal information, we will do so within a reasonable timeframe, unless we are required to retain it for legal or regulatory purposes.
- 2. **Website Information**: We will retain website information, such as the domain name of your website and the IP address of the server where your website is hosted, for as long as necessary to provide web hosting services to you.
- 3. **Usage Information**: We will retain usage information for as long as necessary to analyze usage patterns and improve the functionality of our web hosting platform or website.
- 4. **Communication Information**: We will retain communication information for as long as necessary to communicate with you about our services, including billing and technical support.

- Technical Information: We will retain technical information for as long as necessary to analyze usage patterns and improve the functionality of our web hosting platform or website.
- 6. **Payment Information**: We will retain payment information for as long as necessary to process your payments and comply with accounting and tax requirements.
- 7. **Server Logs**: We will retain server logs for a limited period of time for security and troubleshooting purposes.

We take appropriate measures to ensure the security of your personal information and protect it from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or electronic storage is completely secure, and we cannot guarantee the absolute security of your personal information.

## **Security Measures**

My Digital Bacon LLC takes appropriate technical and organizational measures to protect User personal information from unauthorized access, use, disclosure, alteration, and destruction. These measures include:

- Encryption of personal information during transmission
- Limiting access to personal information to those with a need to know
- Regular testing and evaluation of our security measures

However, no method of transmission over the internet, or method of electronic storage, is completely secure. While we strive to use commercially acceptable means to protect User personal information, we cannot guarantee its absolute security.

### **Access and Correction:**

We strive to ensure that your personal information is accurate and up-to-date. This section outlines our practices for accessing and correcting your personal information.

## **Accessing Your Personal Information:**

When you make a request to access your personal information, we may ask you to provide certain information to verify your identity. We will only use this information for the purpose of verifying your identity.

We will provide you with access to the personal information we hold about you, subject to certain exceptions. For example, we may deny your request if:

- Providing access would pose a risk to the privacy of other individuals
- Providing access would result in a breach of our legal or regulatory obligations
- Providing access would be unlawful
- We are otherwise permitted by law to deny your request

If we deny your request for access, we will provide you with an explanation of our decision.

### **Correcting Your Personal Information:**

If you find that any of the personal information we hold about you is inaccurate, incomplete, or out-of-date, please contact us at support@mydigitalbacon.com. We will respond to your request within a reasonable timeframe.

We will correct your personal information if we are satisfied that it is inaccurate, incomplete, or out-of-date. If we correct your personal information, we will take reasonable steps to notify any third parties to whom we have disclosed your personal information of the correction, where it is reasonable to do so and where required by law.

If we are not satisfied that your personal information is inaccurate, incomplete, or out-of-date, we will take reasonable steps to annotate your personal information to indicate that you have requested a correction.

If we deny your request to correct your personal information, we will provide you with an explanation of our decision.

# **Security of Your Personal Information:**

We take appropriate measures to ensure the security of your personal information and protect it from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or electronic storage is completely secure, and we cannot guarantee the absolute security of your personal information.

### **Opt-Out**

At My Digital Bacon LLC, we value your privacy and provide you with control over your personal information. If you would like to opt-out of any communication from us, please contact our support team at support@mydigitalbacon.com with your request. Please note that opting out of certain communications may impact our ability to provide you with certain services or information.

You also have the option to disable cookies on your browser to prevent us from collecting certain information about your browsing habits. However, disabling cookies may affect your user experience on our website.

#### **Cookies**

The Platform uses cookies to improve the User's experience and to provide customized content and advertising. A cookie is a small text file that a website stores on a User's computer or mobile device when they visit the site. Cookies may be used for various purposes, including but not limited to:

- Authenticating Users and remembering their preferences
- Analyzing how Users interact with the Platform
- Serving customized content and advertising

Users may choose to set their web browser to refuse cookies, or to alert them when cookies are being sent. However, some parts of the Platform may not function properly if cookies are disabled.

We use all, some, or none of the following types of cookies:

**Necessary Cookies:** These cookies are necessary for the Platform to function properly, and cannot be switched off in our systems. They are usually only set in response to actions made by the User which amount to a request for services, such as setting privacy preferences, logging in or filling in forms. Users can set their browser to block or alert them about these cookies, but some parts of the Platform will not then work. These cookies do not store any personally identifiable information.

**Analytics Cookies:** These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our Platform. They help us to know which pages are the most and least popular and see how visitors move around the Platform. All information these cookies collect is aggregated and therefore anonymous. If Users do not allow these cookies we will not know when they have visited our Platform, and will not be able to monitor its performance.

**Advertising Cookies:** These cookies may be set through our Platform by our advertising partners. They may be used by those companies to build a profile of Users' interests and show them relevant adverts on other sites. They do not store directly personal information, but are based on uniquely identifying the User's browser and internet device. If Users do not allow these cookies, they will experience less targeted advertising.

# **Third-Party Services**

### California Consumer Privacy Act (CCPA)

#### **Categories of Personal Information Collected**

In the preceding 12 months, My Digital Bacon LLC has collected the following categories of personal information:

- Identifiers, such as name, email address, and payment information.
- Internet or other electronic network activity information, such as IP address, browser type, and operating system.
- Commercial information, such as purchase history and payment information.
- Geolocation data.
- Inferences drawn from any of the above information to create a profile about a User reflecting the User's preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes.

#### **Purposes of Collection and Use of Personal Information**

#### **Disclosure of Personal Information**

My Digital Bacon LLC may also disclose personal information in response to legal requests, including but not limited to subpoenas and court orders.

#### California Residents' Rights

- The categories of personal information collected.

California residents also have the right to request that My Digital Bacon LLC delete their personal information, subject to certain exceptions.

#### **How to Exercise Your Rights**

#### **Authorized Agent**

California residents may designate an authorized agent to make a request under the CCPA on their behalf. To do so, please provide us with written authorization signed by the California resident and the authorized agent.

#### **Non-Discrimination**

My Digital Bacon LLC will not discriminate against California residents who exercise their rights under the CCPA.

## Your Privacy Rights in the European Union (EU)

My Digital Bacon LLC is committed to complying with the General Data Protection Regulation (GDPR) and providing Users located in the European Union (EU) with the necessary information and tools to exercise their rights under the GDPR.

#### **Legal Basis for Processing Personal Information**

My Digital Bacon LLC processes personal information based on one or more of the following legal bases:

- The User has given consent for the processing of their personal information.
- The processing is necessary for the performance of a contract with the User or in order to take steps at the request of the User prior to entering into a contract.
- The processing is necessary for compliance with a legal obligation to which My Digital Bacon LLC is subject.

#### **Your GDPR Rights**
